#### **European Documentation Centre**

Early in July the Vice-Chancellor signed an agreement with the European Commission establishing the University of Adelaide Library as a Specialized European Documentation Centre. This was the culmination of an extended period of enquiry and negotiation by the University Librarian and several members of the academic community over more than five years. In fact interest in becoming a European Documentation Centre was first shown nearly twenty years ago.

As a result of the agreement the library becomes a deposit library for a wide range of official documents emanating from the European Commission, and also gains access to several related online databases, and some Internet-based sources of European Union information. We expect to begin receiving materials within a month, and will continue to receive them indefinitely, so long as we meet certain conditions set down by the European Commission.

The process of detailed liaison between Library staff and the academic community is just beginning: we aim to promote an awareness that this collection is available and to give all possible assistance in its use. The materials we have selected are likely to interest researchers in several fields. The Library will receive broadly-based documents such as legislation and regulations, case law, and basic statistics. We have also selected ten subject areas:

Agriculture, Silviculture, Fisheries
Employment and Labour
Social Questions
Law and Procedures
Competition and Undertakings
Finance
External Relations
Regional Policy
Environment
Information, Education and Culture

The Library will receive the material in various formats: some will be microfiche, but other material is either paper, or accessible through online databases. As a European Documentation Centre we receive one free licence to each of these databases. They provide valuable indexing of the collection as well as full text documents in some cases.

# **European Documentation Centre** (continued from front page)

The scope and potential of this material is very broad. The University's recently established Centre for European Studies has a clear interest in the collection, but so too have researchers in history, commerce and marketing, agriculture and trade, law, and international politics. Over the coming weeks, Peter Jacobs from Reference Services will be establishing contact with all potentially interested members of the University's teaching staff. His responsibility is to guide the establishment of this collection, and to assist with any questions regarding its use — including the online resources.

With this development we expect to be able to consolidate European Union materials held in the University of Adelaide libraries. Most of the documentation will be housed in the Barr Smith Library in one location; some agriculture-related materials will most likely go to the Waite Campus Library, while a series of law reports will go to the Law Library. The documents are complex in their structure, coding, and indexing, and we

hope that by centralising the collection we will minimise difficulties associated with their use. Our agreement with the European Commission also commits us to maintaining this collection as a discrete and recognisable

entity, as far as practicable, within the University of Adelaide Library.

As a European Documention Centre, the Library undertakes to provide and promote access to this material to the wider South Australian community, not only to researchers and students of the other two universities, but also to other reseachers and scholars in this State.

# Shapcott Inaugural lecture

Thursday 11 September saw the first of the 1997 Inaugural Lectures to be held in the Barr Smith Library's Ira Raymond Exhibition Room. Professor Tom Shapcott, newly-appointed Professor of Creative Writing in the University's English Department, spoke on 'Teaching Creative Writing within a Literary Culture'.

To a comfortably crowded audience he expounded first the notion of creating an Australian literary culture, with all the implications that has for regional identity and literary themes, and the growing confidence of young Australian writers in both those areas. Professor Shapcott touched on the need for retrospect, commenting that 'One of the marks of a culture is the way in which it can ...draw upon its own legacies and antecedents'. He called for a recognition of the 'hugely rich resource base'Australia's literary culture has, and went on to discuss the exciting times we are in, with five concurrent generations of writers 'all contributing at the same time to the creative ferment. This is without precedent or parallel in our culture'.

Teaching writing, Shapcott said, is less about examinations and marking than about what 'can be discussed, debated and exercised on such matters as language — words and perhaps the pauses between words'. The specific task of writers comes down to the essential yet inexact human need for communication; as Anaïs Nin said so eloquently: 'the role for the writer is not to say what we can all say, but what we are unable to say'.

Professor Shapcott closed by saying, 'I'm listening. As a writer that's my job. And as a Professor of Creative Writing that is also my job. And by listening we learn what we know'.
